A memo was received from Cora Sonier, CDC stating the project has reached an impasse, mainly due to the inability to obtain easements from various property owners to enable the Trail to be built. The proposed Trail was moved due to not being able to obtain easements from the CDC and Brennan Farms. The second location for the Trail not possible due to not being able to obtain easements from Strait Crossing and the Government of Canada.

#### 1.CALL TO ORDER:

Mayor Charles Mackenzie called the meeting to Order at 6:00pm who stated that the purpose of the meeting was to discuss the Ellis Family Dance scheduled for Saturday Sept 10, 2022

#### **ELLIS FAMILY DANCE**

On Aug 31<sup>st</sup> the CAO emailed members of Council indicating he felt the Ellis Family Dance needed to be cancelled as ticket sales to date were less than 100 and that 400 tickets would need to be sold for the event to break even. If the dance was cancelled a week in advance the cancellation fee by the production company would 50% of their fee or \$800. If a substantial increase in ticket sales didn't materialize a deficit to the Town could be as high as \$5,000.

A number of members of Council did not feel the Dance should be cancelled and the Mayor agreed the matter be discussed at a special meeting being held this evening. Prior to the meeting several emails were exchanged among members of Council and the CAO.

The matter was discussed in length with members of Council expressing their views on whether the dance should be cancelled or not. During the discussion, the Deputy Mayor arrived at 6:15pm and Councillor Nicole Arsenault left the meeting at 6:30pm

Some members of Council wanted to wait until the middle of the following week to make a decision on the Dance while other members were concerned about minimizing the cancellation costs.

In conclusion, it was the consensus of Council that the CAO approach the Band to see if their production company would extend the time frame to make a decision on the dance until the following Tuesday without the Town incurring a cancellation fee higher than the \$800, and if they did not agree to this request then the CAO was to cancel the dance.

#### 1.CALL TO ORDER:

Mayor Charles Mackenzie called the meeting to Order at 7:00pm who stated that the purpose of the meeting was to discuss and consider three tender items including meeting with our engineer Jonathan Doyle, WSP in respect to the tender for Sewer services on Read Road.

#### 2. DISCLOSURE OF CONFLICT OF INTEREST

Part VI, Section 23 of the Municipalities Act, which maintains that No member of Council shall derive any profit or financial advantage from his/her position as a member of Council and, where a member of Council has any pecuniary interest in or is affected by any matter before the Council, shall declare his/her interest therein and abstain from voting and discussion thereon.

No one present declared a Conflict at this meeting.

#### 3. NEW BUSINESS

3.1 Tender Specs – READ RD Sewer Project – Review with Jonathan Doyle, WSP Johnathan Doyle, WSP was present at the meeting and reviewed with members of Council the detailed drawings and tender specifications for an 8" (200mm) Sewer to be installed on Read Road from Carleton Street to the Sewer Lift station at the bottom of Industrial Drive. Mr. Doyle answered various questions as put to him by members of Council.

A revised estimate for the Sewer was circulated totaling \$553,761.34. The original estimate was \$353,138.63. Council agreed that the tender should be issued to be completed in the Spring of 2023.

It was duly moved and seconded that the CAO be requested to apply for approval from the Infrastructure Secretariat to use unallocated Direct Allocation Gas Tax Funds to cover the increased cost of the Sewer on Read Road from \$353,000 to \$554,000.

Moved by Deputy Mayor Randy Ahearn, seconded by Councillor Nicole Arsenault.

Motion Carried 6-0 (R#22-09-01) Mr. Doyle left the meeting at this time.

#### 3.2 Ball Field Project - Revision to Contract Potential Savings

The CAO reported that Council had previously agreed to award to Eastern Fence the replacement of the Ball Field backstop, players benches sideline fence and outfield fence at a cost of \$56,500 plus HST with an additional \$2,000 allocated for the Town to remove and dispose of the existing fencing and dugouts.

Staff did a walk around the existing fence and felt that the outfield section of the fence was in good shape and did not need to be replaced.

It was duly moved and seconded that the contract with Eastern Fence be amended with the existing Outfield Fence not be replaced for an estimated savings of \$15,000.

#### 3.3 Snow Removal Tender Documents

The CAO circulated draft tender documents for the Snow Removal of Town owned streets and three parking lots in the Town. (Fire Hall/Library; Town Hall; Gateway Arena). Plowing of sidewalks were not included in the tender. The closing date of the tender would be Sept 30<sup>th</sup> and the duration of the tender was 3 years.

It was duly moved and seconded that the Snow Removal tender for the town owned streets and parking lots be issued as per specifications circulated to members of Council.

It was noted that the tender was for contractors to bid on snow removal of the streets, or snow removal of the parking lots or both.



#### Introduction

On behalf of Mayor Charles Mackenzie and the Town Council of the Town of Borden-Carleton, we thank the Honourable Minister Ahmed Hussen and our MP Heath MacDonald for taking the time to meet with us to discuss Housing needs in our communities in PEI. We appreciate the opportunity.

We feel the timing is right for all levels of government to focus on increasing the housing stocks in small urban and rural areas. Past focus seemed to be on the cities across Canada and huge developments. A number of small developments has a lot of benefits as well.

#### Town of Borden-Carleton

The Town of Borden-Carleton is a small town on the west coast of PEI and is known as the Gateway to the province as it is where Confederation Bridge meets PEI. Housing Development in the town has been sparse over the past five years, however it has the potential to a "gem" of development in PEI for years to come.

#### **Immediate Housing Needs**

<u>Employee Housing</u> in the Town and surrounding area there are many major manufacturing, commercial, farming, fishery and retail companies that have been telling us there is a huge shortage of rental units for their works. Ma

<u>Moderate Priced Homes</u> – Prices of Housing has been on the rise and families looking for homes that are affordable is becoming a challenge. The province recently proposed 6 1,000 units in the Town but the project was shelved because the cost just for the buildings were \$350 per sq ft.

#### **Senior Downsizing**

A number of larger older homes are owned by Seniors who are looking to downsize and live in low maintenance housing. There is a lack of seniors housing units in the Town.

For the past couple of years, the Town has been promoting Borden-Carleton as a Designation for business, residents and visitors to PEI. Council is committed to continue show casing Borden-Carleton as a bright spot in the future of PEI and to encourage economic growth throughout Borden-Carleton.

#### What Borden-Carleton has to Offer

Welcoming Community – We are a welcoming community, welcome diversity.

The Jobs are Here – Jobs , jobs, jobs! Many of the businesses in the area are hiring (but housing is needed)

Quality of Life – The Town is a quiet, safe, friendly little town. Everyone knows everyone. Children are only minutes away from the school and library and workers are only minutes away from the workplace. No communing an hour or more twice a day fighting city congestion.

Strategy Located – The Town is only 30 minutes from Summerside, one hour from either Charlottetown or Moncton.

The Bridge – Millions of cars and trucks cross the Confederation Bridge every year. What a better place to live and still have easy access to visit other parts of Canada or have relatives come visit you here.

Land Prices- Also land prices are rising, land for development in Borden-Carleton is much cheaper than purchasing the same property in the larger towns and cities.

To Whom It May Concern,

As members of the Breaking Barriers Together Association, we would like to thank you for taking the time to read our letter and we would like to introduce ourselves.

We are a group of former employees of Canada's Royal Canadian Mounted Police who have formed a not-for-profit association to lobby Canadians to push for large-scale change in the operation and structure of our national police force and military.

As you are aware, both the RCMP and Canadian Military have been plagued for decades with serious, often criminal, allegations of internal misconduct and abuse. These problems are always said to be "cultural" issues that the government claims to be working on.

This type of behaviour however, was sponsored by the Government of the Day, in the 1950's - 1990s, with internal purging of employees of the Canadian Government, National Defence and the Royal Canadian Mounted Police, known as the "Purge". Hundreds of employees, from many departments were fired, interrogated, for being LGBTQ. A class action also followed in recent years as many as over 750 persons were involved.

As victims of this systemic abuse, we have joined together with the goal of letting Canadians know just how little has been done to address this issue which is pushing some officers and staff to suicide. By showing the seriousness of this issue, we believe it can become a voting issue for Canadians and that will push those in power to make the changes that have been recommended for years but have consistently been ignored.

In 2012, a group of women who had been sexually harassed, raped and abused within the RCMP came together and filed a class action law suit against the RCMP and federal government. More and more came forward with very disturbing and serious allegations. After 4 years in court, arguing for



certification of our case, the federal government offered a settlement to the victims. Over 3200 women came forward which was triple the predictions of our lawyers, who suspected it may grow to 1000.

That shows how serious the problems within the force were and continue to be. Our case ended in 2016 with a national public apology, a financial settlement of more than \$125 million and commitments to change the force. To date, absolutely nothing has been done. We hear from current victims quite often and we know that neither the 3200 victims, the national apology, the settlement paid nor the promise to do better mattered enough to the government to warrant the political will to change. Promises and recommendations have been ignored, and the abuse continues.

The vast majority of the RCMP consists of honest, hard working, ethical humans who have sworn an oath to uphold the law and serve their communities. In the Communities where the RCMP are contracted to serve, municipal employees in that detachment deserve a harassment free workplace in all aspects. If there is no recourse available to those Municipal Employees, the RCMP has failed them as well as their own employees. The municipal employees deserve as much protection as do RCMP/PSEs and Civilian Members. If anything, there is no record of voices from these employees and how they have been affected by the lack of responsibility by the RCMP. It is time that these employees be recognized as part of the change. This involves many of us, from Current Members, Civilian Employees, Public Service Employees, Municipal Employees and other support staff. From non union to union members who have been excluded from many of the lawsuits. It affects us all, families, neighbours and friends.

From our 2012 law suit, 2 other large class actions were launched. One for those who suffered systemic internal racism and another for generalized harassment and bullying which is expected to be in excess of \$1.2 billion in costs. Many officers and staff have filed their own law suits and had them settled in their favour, adding to the vast amount of Canadian taxpayer dollars being spent to pay out for RCMP misconduct.

It is interesting to note, that when these cases are filed, we (the plaintiffs/ victims) pay our legal expenses out of a portion of our settlement. The RCMP and government have every dollar of their side of the litigation paid for by the Department of Justice. They can keep cases in the courts for years at the expense of taxpayers. We need your help to change that.

In recent days, we have seen the story of sexual misconduct in Canada's hockey association. The response has been rapid with funding cuts, sponsorships halted and immediate questions from the Minister of Sport demanding answers and requesting that if those who have the power to address and change this continue to do nothing, then get out and let people who can change the situation take over. We wonder why the Minister of Public safety has never taken a similar stance in support of RCMP abuse victims. We ask questions but get no answers. That is where you can help.



The Canadian government has known of the problems in the RCMP for decades and have paid millions of dollars on numerous studies to be completed by experts and scholars. There have been at least 17 of these studies done on misconduct. EVERY SINGLE STUDY EVER COMPLETED BY THESE EXPERTS HAVE RECOMMENDED ONE THING CONSISTENTLY. THAT IS THE CREATION OF AN INDEPENDENT BODY OF INVESTIGATION AND OVERSIGHT TO DEAL WITH MISCONDUCT BECAUSE THE RCMP HAS FAILED MISERABLY TO ADDRESS THIS ISSUE ON THEIR OWN.

Breaking Barriers Together are reaching out to all of the groups and individuals that may be unaware of just how bad things are in our national police force and military and we want to see how our problem is indirectly yours also. You can make change with your help. We have a simple ask thing to ask of you.

Earlier this year, we saw the introduction of Bill C-20 which will begin the creation of independent oversight, but it's not done yet. The Bill will be revisited this fall and we want to ensure Canadians are on board to pressure the government for them to see the importance of this Bill passing.

Re: Amendments to the Special Planning Areas Regulations under the Planning Act Subdivision and Development Regulations

The *Planning Act* Subdivision and Development Regulations were recently amended. Many of these amendments were housekeeping and minor corrections; however, some of these amendments are related to the Charlottetown, Summerside, Cornwall, and Stratford Special Planning Areas (SPA) for which some municipalities may be directly impacted. The recent amendments were adopted on April 9<sup>th</sup>, 2022 and June 11th, 2022. Additionally, there were older amendments from October 2019 that were not officially communicated to the Federation at that time. Please see attached amendments and rationales for your information.

In addition to the attached regulatory amendments, the Department would like to announce a Government initiative to replace the existing PEI Planning Decisions website currently being used by the Province and many municipalities. There is work currently underway and the Department hopes to have a new Planning Decisions website by the end of the year. As this initiative impacts many municipalities, the Department welcomes input from anyone wishing to assist with the improvement of the website. As well, if anyone is interested in taking part in the testing of the new website, please contact our department as your participation would be welcome and appreciated.

The Department will need names of all individuals who will require access to the new website in order to upload municipal planning decisions. Please forward the municipality name with all contact person(s) names, telephone numbers, and email addresses) to Katie Winter at <a href="mailto:kbwinter@gov.pe.ca">kbwinter@gov.pe.ca</a>.

As always, we appreciate the collaborative partnership that we share with your organization and thank you for your continued support in ensuring the province maintains a strong relationship with municipalities on land related decisions. The Department of Agriculture and Land will continue to provide updates on future amendments, as well as actively engage the Federation on any matters that may impact municipalities.

### Planning Act Subdivision and Development Regulations Amendments and Rationales:

### October 12, 2019

**63.(4)** An existing parcel of land may, on approval, be subdivided into <u>not more than one lot for one of the following purposes:</u>

- (a) recreational use;
- (b) resource-commercial or resource-industrial use, where the lot is intended for agricultural, forestry or fisheries purposes;
- (c) institutional use, where the lot has an area no greater than three acres;
- (d) use as a cemetery;
- (e) rural tourism use, where the area of the lot does not exceed three acres;
- (f) public utility use.

Rationale: Subsection 63.(4) was amended to removed non-resource related commercial uses in the Special Planning Areas to be more in keeping with the overall objective to minimize conflicting land uses. The previous wording allowed for one lot for each use, meaning one could potentially be permitted to subdivide up to 6 lots all for very different land uses. Again, this was contrary to the main objectives of the Special Planning Areas. As a result, the wording was amended to state only one lot could be permitted in total and the developer would be required to choose which type of use they required. As well, the addition of a public utility use was added to ensure important infrastructure could be permitted in these areas.

- 63.(4.1) A parcel may be subdivided for a non-resource related commercial or industrial use where
  - (a) the subdivided land is to encompass or contain an existing commercial use, or be appended to or consolidated with land that was approved for a non-resource related commercial or industrial use by the Minister prior to October 12, 2019;
  - (b) in the opinion of the Minister, that use has not been discontinued or abandoned; and
  - (c) the proposed expansion does not violate the intent and purpose of these regulations, with particular regard for sections 3 and 13.

Rationale: Although the provision to allow non-resource commercial uses was removed, there was still a desire to allow existing commercial uses to expand, adhering to the above criteria.

### April 9, 2022

**63.(4.01)** An existing parcel of land may, on approval, be subdivided into not more than five lots for residential use, which may include

- (a) single-unit dwelling use;
- (b) duplex dwelling use; or
- (c) multiple unit dwelling use or a mobile home park where
  - (i) central sewerage service provided by a municipal sewerage utility or central water service provided by a municipal water utility, or both, are available, and
  - (ii) an irrevocable agreement has been signed between the developer and the municipal sewerage or water utility to provide central sewerage service or central water service, or both, if available, to the lot or mobile home park.

Rationale: 63.(4.01) was added to allow up to five lots for residential use in the Special Planning Area. As the SPA has been in place since July 9<sup>th</sup>, 1994, increasing housing demands from the public have resulted in the need to provide development potential near the larger population centers. This amendment further aligns with the existing provision under 63.(10), which already existed to provide municipalities with an official plan and bylaws to permit up to five lots for residential use.

**63.(10)** A municipality with an official plan may, as an alternative to amending its official plan and bylaws to conform with subsections (2) to (9), otherwise amend its official plan and bylaws where the amendments comply with subsection 7(2) of the Act and

- (a) are consistent with the objectives set out in subsection (3);
- (b) satisfy the minimum requirements applicable to official plans pursuant to section 7 of the Act;
- (c) revoked by EC421/09;
- (d) with the exception of the community of Miscouche, <u>limit the number of lots in a subdivision for residential use</u> to no more than five lots per existing parcel of land, unless
  - (i) central water service, central sewerage service, or both of them, by a municipal water utility, municipal sewerage utility, or both of them, is available, and
  - (ii) an irrevocable agreement has been signed between the developer and the municipal water utility, municipal sewerage utility, or both of them, to provide central water service, central sewerage service, or both of them, to all lots prior to the conveyance of any lot from the approved subdivision; and
- (e) require the municipality to report to the Minister, on or before April 30 of each year, the number of lots approved and development permits issued in the previous fiscal year, by type of intended use.

Rationale: Subsection 63.(10) is a provision designed to enable a municipality with a land use plan and accompanying bylaws to avoid the rigid provisions of the SPA and to be able to approve a multi lot subdivision based on approximate development growth, within certain parameters. It is clear under the provisions of subsection 63.(10)(a) that those official plans must still comply with the overall objectives for development within the SPA.

**63.(4.02)** For greater certainty, the same parcel of land may be subdivided for the purposes of either subsection (4) or (4.01), but not both.

Rationale: 63.(4.02) states that one must choose either 63.(4) or 63.(4.01) but not both, meaning, if you choose five residential lots, other uses cannot be permitted and vice versa.

#### June 11, 2022

**63.(5)** Notwithstanding clause (4.01)(a), where the intended residential use is single-unit dwelling use, subdivisions of more than one lot per parcel of land, may be approved in the following situations: (a) where the requirements of clause (4.01)(a) are insufficient to permit the owner of a parcel to provide lots for the children of that owner, and

(i) the owner files, with an application to subdivide the parcel, a statutory declaration that he or she will convey the lots only to his or her children and only for the use as a single-unit dwelling, (ii) no child of the owner will receive more than one lot,

(iii) the total number of lots that may be subdivided from all of the parcels owned by an owner pursuant to this subsection is equal to or less than the number of children of that owner at the

time of the application, and

(iv) revoked by EC166/08) (v) a lot intended for a child of the owner of a parcel of land shall not be given final approval and shall not be conveyed until the child has received a development permit approval for the lot and has submitted a statutory declaration declaring that the child intends to build a residence on the lot for the child's own use;

- (b) where one lot is required in addition to those permitted by clause (a) or (4)(a) in order to accommodate an existing farm dwelling, and the dwelling on the lot is to be served by the existing farm dwelling access;
- (c) where central sewerage service provided by a municipal sewerage utility or central water service provided by a municipal water utility is available or both are available, and an irrevocable agreement has been signed between the developer and the municipal sewerage or water utility to provide central sewerage service or central water service or both if available to all lots prior to the conveyance of any lot from the approved subdivision;
- (d) where an owner of a golf course that exists on the date of the coming into force of this clause proposes to create a golf course development in accordance with the requirements of subsections (5.03) to (5.05).

Rationale: 63.(5) states the circumstances for which additional lots may be permitted in addition to those permitted under Section 4, 4.1 and 4.01. For this amendment, the word 'existing' was removed to allow additional lots from a parcel of land that is not considered 'existing'. At this time, 'existing' is defined as any parcel of land created prior to July 9, 1994. This amendment would allow parents of non-existing parcels to subdivide a lot for each of their children, if the provisions of 63.(4.01) were insufficient to do so.

The Department of Fisheries and Communities, will be launching the second round of the Youth-on-Board Program in early Fall 2022 and with this great news, we are seeking expressions of interest from Boards interested in mentoring youth.

Youth-on-Board Program is designed to encourage youth volunteerism within rural regions of Prince Edward Island and to expand the capacity of mentoring Nonprofits and Municipal Administrations. The Program will offer a platform for up to 40 students to become involved as members of active Island Boards or within a rurally based Municipality. The program strategically matches rural youth (grades 10-12) with NGOs of their interest for up to 8 months; the youth will attend monthly Board Meetings while being supported by a designated Mentor of your organization.

### **OBJECTIVES**

- Engage youth within the non-profit sector of their interest to highlight the role(s) that nonprofits play within rural PEI:
- Introduce youth and/or deepen understanding of municipal government functionality;
- Deliver Governance Training for up to 40 Island students prior to the Youth-on-Board placement commencement;
- Offer a platform to build capacity within rurally based Nonprofit/Municipal Administrations;
- Provide mentorship, guidance and education for youth throughout the duration of the placement on the Board (October 2022 – May 2022);

### Quick Stats from 2021/22 Youth-on-Board Pilot:

- > 80% of participating NGOs indicated that the Youth-on-Board Program provided capacity building at some level within their organization
- 100% of participating NGOs indicated that they would recommend the Program to another organization
- 88% of participating NGOs stated that there was an opportunity for the youth to stay involved with the organization following the Youth-on-Board Pilot

### Interested Mentoring nonprofits must meet the following eligibility criteria:

- Incorporated nonprofits within rural PEI or clearly demonstrate an Island-wide mandate/reach;
- Rurally positioned Municipal Government;
- Completion of a one-hour Mentorship Training session and provide the name of a designated Mentor to support the student's learning curve;

- Facilitation of monthly Board meetings which will offer the student an engaging learning environment;
- Allow RRD staff to conduct a minimum of two monitors during the duration of the Program and submit a Program Evaluation Form by June of 2023;
- Honorarium: Participating Nonprofits and Municipal Governments who successfully host a Youth-on-Board Student
  will receive an honorarium upon completion of the program evaluation feedback form, the amount is determined
  on a sliding scale, as determined, below.

### **RE: Harm Reduction Services and Supports in PEI**

To our Municipal Partners,

The PEI Department of Health and Wellness would like to share information with Municipalities on Harm Reduction Services and Supports in PEI.

In Canada and PEI, drug related overdoses are on the rise. This is driven largely by fentanyl, which has made the illicit drug supply more toxic. Working alongside treatment and prevention, harm reduction saves lives and helps build healthy and safe communities. The PEI Department of Health and Wellness is developing new <a href="Harm Reduction Services">Harm Reduction Services</a> and Supports across PEI. This is in addition to currently available services such as free naloxone kits and the <a href="Needle Exchange Program">Needle Exchange Program</a>.

Supervised consumption is an effective, evidence-based harm reduction service proven to save lives and promote both public health and public safety. To that end, an Overdose Prevention Site is being developed in the capital region. For rural and suburban communities, phone-based overdose response services are currently available to all Islanders.

The <u>National Overdose Response Service</u> (NORS) and the <u>Brave App</u> are phone-based overdose response services. Both NORS (a phone line) and Brave (a phone app) connect people to trained peers and staff so that they are less likely to use drugs alone – which is a significant risk factor for overdose deaths. If a caller becomes unresponsive, then a safety plan is activated so the person can receive emergency assistance. Both services are accessible 24/7 and are free, confidential and non-judgmental.

### Re: RCMP Policing Extended Service Agreement

In accordance with the *Policing Extended Service Agreement* (PPSA) between the Town of Borden-Carlton and the Province of Prince Edward Island, "the Government shall provide policing services to the Municipality equivalent to that of one member of the Royal Canadian Mounted Police during a normal work year".

In addition, in accordance with Amendment No. 1 the Municipality agrees to pay to the Province an annual sum for the direct costs for one RCMP Constable to carry out their duties under this Extended Service Agreement. Due to this Amendment, the recovery cost was reduced from \$152,447 to \$98,287 for the fiscal year 2021-2022. Per Section 1(c) of Amendment No. 1 the direct cost items are subject to annual collective agreement increases and any other increase to those direct costs as determined under the PPSA.

The Province has been notified by the RCMP "L" Division that the direct costs under the Provincial Policing Agreement for 2022-2023 will increase from \$98,287 to \$105,303 for one Police Officer commencing April 1, 2022.







This is a follow up to the Town's request sent January 28<sup>th</sup> that the province take over the maintenance of Town Streets within the Town of Borden-Carleton. (see attached) As of today's date, we haven't received a response and we are wondering what is the status of our request,

More importantly is the concern in respect to the Town's ability to be able to provide snow removal on our streets this fall (2022). We had a three year snow removal contract that expired April 30 2022. For the past two years our contractor had difficulty obtaining liability insurance coverage. Last year our contractor's liability insurance cost increased from \$23,000 to \$68,000. As a result we were charged a surcharge of 15,000 in 2020/21 and 19,500 in 2021/22 by our contractor on top of the snow removal contract fees.

A number of small contractors can not absorb these higher liability insurance costs and we are concerned whether we will get anyone even to bid on our tender call this fall.

Our request to the province is two fold. The initial request is for the province to take over responsibility for all streets in the Town. In the interim, we are requesting that the province assist the Town by adding the streets in the Town for snow removal to the provincial snow removal contract.

We would appreciate consideration of our request at your earliest convenience.

### Town of Borden-Carleton Municipal Residential Property Tax Incentive Policy 2022-06-01

1.0 Housing Imitative

1.1 Construction of a new home with an assessment of at least \$100,000

1.2 Construction of a new apartment building assessed at least

\$100,000 per dwelling unit.

1.3 Incentive applies to initial owner only and terminates once the property is sold. It is not transferable to subsequent owners of the

property

1.4 Incentive only allowed to be used one time per property. For multi building housing projects built in phases, the incentive will apply as each building is completed and occupied as per signed separate agreement with the developer.

1.5 Incentive applies to year-round, owner occupied or tenant

property.

- 1.6 Tourism, cottages, seasonal, short- term rentals and nonresidential properties are not eligible for the municipal tax incentive.
- 1.7 Change of use of an existing structure will not make the property eligible for a municipal tax incentive.
- 2.0 Eligible applicants will receive a tax refund as follows:

2.1 For owner-occupied single-family homes: a 100% rebate for 5 years on the <u>Municipal portion</u> of their residential property tax.

2.2 For apartment buildings, built and 75% occupied prior to December 31, 2025: a 100% rebate for 5 years on the <u>Municipal</u> portion of their residential property tax

2.3 For multiple housing projects on the same lot built in phases and an agreement is in place as per section 1.4: a rebate for each building as per the terms outlined in the agreement.

2.3.1 Not withstanding the terms of the agreement, the rebate of the <u>Municipal portion</u> of the taxes shall not exceed 5 years for each individual building.

- 2.4 For all apartment buildings built and occupied after December 31, 2025 and for all multiple dwelling agreements signed after December 31, 2025, a phased tax incentive will apply once buildings are complete and 75% occupied:
  - For year one 100% rebate for 5 years on the <u>Municipal</u> portion of their residential property tax, and
  - For year two 80% rebate for 5 years on the <u>Municipal</u> portion of their residential property tax, and
  - For year three 60% rebate for 5 years on the <u>Municipal</u> <u>portion</u> of their residential property tax, and
  - For year four 40% rebate for 5 years on the <u>Municipal</u> portion of their residential property tax, and
  - For year five 20% rebate for 5 years on the <u>Municipal</u> <u>portion</u> of their residential property tax, and

### 3.0 Administration of the tax incentive program

- 3.1 An applicant must fill in an application form each year and return it along with a copy of their P.E.I. Real Property Tax bill, to the Municipal Office, 20 Dickie Road (Box 89), Borden-Carleton CoB 1X0 prior to December 31<sup>st</sup> in any given taxation year.
- 3.2 The CAO may require proof of payment of property taxes prior to issuing an incentive payment to the property owner.
- 3.3 Any payment will be issued to the assessed owner of the property.
- 3.4 The CAO may deduct from the incentive payment, amounts to cover any outstanding fees or other charges owed to the town including and not limited to utility billings, servicing charges, permits, fees and fines.
- 4.0 interpretation and termination of Incentive Program
  - 4.1 The Council of the Town of Borden-Carleton may amend or terminate the municipal residential property tax incentive by motion of Council at a duly held meeting of the Council.
  - 4.2 If any dispute arises in respect to the application and interpretation of any provisions of this document, the opinion of the Town shall prevail and be final.

# Town of Borden-Carleton Recognition of Service – Volunteer Firefighters Policy 2022-09-01

### 1.0 Volunteer Fighters

- 1.1 The Town recognizes that volunteer firefighters are men and women from the community and district who volunteer their time to serve as 1<sup>st</sup> responders with the Borden-Carleton and Area Fire Dept
- 1.2 Considerable hours are involved each year to respond to Fire and other emergency calls, attend practices and take the necessary training at their own expense to keep our community safe.
- 1.3 Dedicated individuals continue to serve the community year after year.

### 2.0 Suitable Recognition for Long Service

- 2.1 On an annual basis Council shall recognize those Firefighters who reach certain milestone serving the Community: 20 Years service; 30 Years service; and 40 years service
- 2.2 Prior to the Annual Firefighters dinner held in September each year, the Fire Chief shall notify the CAO those firefighters who have reached a service milestone as per clause 2.1
- 2.3 Service recognized shall be the service according to the records of the Borden-Carleton and Area Fire Dept.

### 3.0 Service Award

- 3.1 The Town shall provide to qualified firefighters the following service awards:
  - Upon completion of 20 years service \$200
  - Upon completion of 30 years service \$300
  - Upon completion of 40 years service \$400
- 3.2 The presentations will be made at the Annual Firefighters Dinner held in September each year by a member of Council.
