CAO's REPORT

At a Council meeting held on Nov 19, 2020, Council passed a motion to proceed to public consultation to consider to:

- Amend Appendix 1 General Land use Plan of the Official Plan in order to change the designation for PID#778936 from Residential to Commercial; and
- Amend Appendix "A" Zoning Map of the Zoning and Development Bylaw in order to rezone PID#778936 from the Residential (R1) Zone to the Highway Commercial (C2) Zone

To allow the expansion of the KOA Campground.

On Dec 07, 2020 the Province of PEI announced its COVID-19 Circuit Breaker guidelines that restricted public gatherings that meant a delaying in holding a Public Hearing in respect to the Rezoning request.

Effective Dec 21, 2020 the Province relaxed their COVID-19 guidelines that would permit public gatherings under certain circumstances for up to 50 persons. By an email poll with Council, it was agreed that a Public Hearing would be held at the Royal Canadian Legion, 240 Main St Borden-Carleton at 7:00pm on Tuesday January 05, 2021.

On Dec 17th, letters were sent to all property owners within 100ft of the lot being considered for rezoning. (No letters were returned by the Post Office).

On Dec 18th, public notice of the Hearing in respect to the Rezoning request was published on the Town's website.

On Dec 18th, public notice of the Hearing in respect to the rezoning request was posted at: Town Hall, Cereitti's Grocery and Hardware store, Tim Hortons, Post Office and Gateway Arena.

On Dec 22nd and Dec 23rd 2020, the Public Notice in respect to the rezoning request was published in the Guardian Newspaper

As of December 31st, two (2) persons as well as the applicants indicated their intention to attend the public hearing on January 5th.
